COMPLAINT FOR VIOLATION OF INTERNATIONAL LAW AND DAMAGES

I. PARTIES

1. **Plaintiff:** Gods of CivEarth, hereafter referred to as “Plaintiff” or “Gods of Civ,” is a sovereign nation and founding member of the United Nations, with rights and responsibilities derived from the UN Charter and other international instruments.
 2. **Defendant:** The Town of 8Ball, hereafter referred to as “Defendant” or “8Ball,” is a sovereign or semi-autonomous entity and a signatory to the United Nations Charter, and thereby bound by its terms and obligations.

II. JURISDICTION AND VENUE

3. This Court has jurisdiction under Article VI, Clause 2 of the GOC Constitution (Supremacy Clause), the United Nations Charter, and international customary law.
 4. Venue is proper in this Court pursuant to 28 G.O.C.C. § 1391 and analogous international tribunal procedures, as the consequences of Defendant's actions have extraterritorial implications.

III. STATEMENT OF FACTS

5. On or about the date of filing, the Defendant engaged in actions that contravened multiple provisions of the United Nations Charter, to which it is a signatory.
6. Specifically, the Defendant violated:
 - **Section 8.1B**
 - **Section 8.2:**
 - a) The Defendant interfered in the domestic affairs of other member states without express consent and in a manner that constituted a violation of sovereignty.
 - b) The Defendant's actions caused **significant international consequences**, including:
 - i. Threats to regional or global peace and security.
 - ii. Severe violations of human rights and international law, including the unlawful detention and/or mistreatment of foreign nationals, and disregard for internationally recognized protections.

IV. ALLEGATIONS OF RACIAL DISCRIMINATION

7. The Plaintiff further alleges that the Defendant engaged in **discriminatory practices or policies** targeting persons of specific racial, ethnic, or national origin.
 8. Evidence will be presented indicating:
 - Disproportionate enforcement of laws or restrictions on entry/movement of specific racial groups.
 - Official communications or laws from the Defendant containing racially biased language or intent.
 - Patterns of exclusion or mistreatment documented by third-party observers or international agencies.

V. CLAIMS FOR RELIEF

9. **Count I** – Violation of UN Charter Articles 8.1B and 8.2
10. **Count II** – Interference in Sovereign Affairs Without Consent
11. **Count III** – Threat to International Peace and Security
12. **Count IV** – Racial Discrimination and Human Rights Violations

VI. DAMAGES

13. Plaintiff seeks compensatory and punitive damages in the amount of:
 - **[\$Fifty Thousand]** for direct economic losses.
 - **[\$One Hundred Thousand]** for humanitarian aid and refugee support resulting from Defendant's actions.
 - **[\$One Hundred and Fifty Thousand]** in punitive damages to deter future violations.
 14. **Total Relief Sought:** \$[Three Hundred and Fifty Thousand]
 15. Funds may be recovered from:
 - Confiscated assets held by Defendant or associated individuals/entities.
 - Trade tariffs or sanctions levied on the Town of 8Ball.
 - Server Balances of individual town members.

VII. PRAYER FOR RELIEF

WHEREFORE, Plaintiff respectfully requests this Court to:

1. Declare that the Defendant has violated Articles 8.1B and 8.2 of the UN Charter.
 2. Order immediate cessation of all unlawful actions by the Defendant.
 3. Award compensatory and punitive damages as outlined above.
 4. Impose appropriate international sanctions or monitoring.
 5. Grant such other relief as the Court deems just and proper.
